



INVITATION TO BID

REPAIR OF RORO RAMP 2A & 2B AND RORO BAY 3/PIER 3 (FORMERLY FASTCRAFT PIER APPROACH) INCLUDING FENDERING SYSTEM, PORT OF ZAMBOANGA, ZAMBOANGA CITY
(ZAM-PGEPSC-04-2020/EP-03-2020)

The Philippine Ports Authority, Port Management Office of Zamboanga (PPA, PMO-Zamboanga), through the Corporate Budget of the Authority for CY 2020, intends to apply the sum of ₱19,802,051.29, being the Approved Budget for the Contract (ABC) to payments under the contract for the Repair of Roro Ramp 2A & 2B And Roro Bay 3/Pier 3 (Formerly Fastcraft Pier Approach) including Fendering System, Port of Zamboanga, Zamboanga City with Project Identification Number: ZAM-PGEPSC-04-2020/EP-03-2020. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Philippine Ports Authority, Port Management Office of Zamboanga now invites bids for the above Procurement Project. Completion of the Works is required 313 calendar days. Bidders should have completed a single largest contract, equivalent to at least fifty percent (50%) of the ABC. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act.”

Interested bidders may obtain further information from the Philippine Ports Authority, Port Management Office of Zamboanga Bids and Awards Committee (BAC) and inspect the Bidding Documents at the address given below during 8:00 AM to 5:00 PM, Monday to Friday.

A complete set of Bidding Documents may be acquired by interested bidders starting December 21, 2020 from the given address and PPA Website upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of TWENTY FIVE THOUSAND PESOS (₱ 25,000.00). The PPA, PMO-Zamboanga shall allow the bidder to present its proof of payment for the fees in person.

The Philippine Ports Authority, Port Management Office of Zamboanga Bids and Awards Committee (BAC) will hold a Pre-Bid Conference on December 28, 2020 at 10:00 AM at the PPA Conference Room, 2nd Floor Admin. Bldg., Port of Zamboanga, Zamboanga City, and/or through webcasting via Zoom, which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before 10:00 AM of January 15, 2021. Late bids shall not be accepted.

Bid opening shall be on January 15, 2021 at 10:00 AM, PPA Conference Room, 2nd Floor Admin Bldg, Port of Zamboanga, Zamboanga City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The Philippine Ports Authority, Port Management Office of Zamboanga reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
