INVITATION TO BID

SUPPLY, DELIVERY AND INSTALLATION OF ADDITIONAL AIR CONDITIONING UNITS FOR PPA, PMO-BOHOL FOR CY 2016

1. The *PHILIPPINE PORTS AUTHORITY, PORT MANAGEMENT OFFICE OF BOHOL*, through the *PPA Corporate Funds* intends to apply the sum of *ONE MILLION THREE HUNDRED THOUSAND PESOS (Php1,300,000.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for the *supply, delivery and installation of additional equipment for the following:*

- A. *Air Conditioning units, 2.5HP window Type,(7 units)* -*Php 350,000.00*
- B. *Air Conditioning units, 5-Tonner Floor Mounted,(10 units)* -*Php 950,000.00*

TOTAL ABC AMOUNT - *Php1, 300,000.00*

Bids received in excess of the ABC shall be automatically rejected during the bid opening.

2. The *PHILIPPINE PORTS AUTHORITY, PORT MANAGEMENT OFFICE OF BOHOL* now invites bids for the *Supply, delivery and installation of Additional Air conditioning units for the Passenger Terminal Building-Jagna, Terminal Management Offices and Multi Purpose Hall, New PMO Administration Building*. Supply, delivery and installation of the goods is required *within 60 calendar days after the issuance of Notice to Proceed/Award*. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act (RA) 5183 and subject to Commonwealth Act 138.

4. Interested Bidders may obtain further information from *PHILIPPINE PORTS AUTHORITY, PORT MANAGEMENT OFFICE OF BOHOL* and inspect the Bidding Documents at the address given below during *Mondays to Fridays 8:00AM to 5:00PM*.
5. A complete set of Bidding Documents may be purchased by interested Bidders on November 15, 2016 to December 6, 2016 from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Pesos *FIVE THOUSAND PESOS only (Php 5,000.00), inclusive of 12% VAT*.
6. The *PHILIPPINE PORTS AUTHORITY, PORT MANAGEMENT OFFICE OF BOHOL* will hold a Pre-Bid Conference on November 23, 2016 at 2:00 PM in *the Conference Room, PMO-Bohol Administration Building, Port Area, Tagbilaran City, Bohol*, which shall be open only to all interested parties who have purchased the Bidding Documents.

7. Bids and eligibility requirements must be delivered to the address below on or before 10:00 AM December 6, 2016. All Bids must be accompanied by a bid security in any of the acceptable forms and amount:

8. Tax Clearance or latest Tax Returns (for newly registered business) must be submitted along with the bid proposal in accordance with *BIR Regulations No.1-2016*. Failure to do so shall be a ground for non-acceptance of the bid proposal.
9. The PPA, PMO-Bohol reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
