

## Invitation to Bid

### Repair for the Maintenance of RoRo Berth at Babak Port Island Garden City of Samal

The **Philippine Ports Authority – Port Management Office of Davao**, through the **Corporate Budget** for the contract approved by the governing Board for **CY 2016** intends to apply the sum of **PESOS: Twenty-Nine Million Nine Hundred Seventy Thousand Nine Hundred Eighty-One Pesos and 62/100 Only (Php29,970,981.62)** being the **Approved Budget for the Contract (ABC)** to payments under the contract for **Repair for the Maintenance of RoRo Berth at Babak Port, Island Garden City of Samal**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Philippine Ports Authority - Port Management Office of Davao now invites bids for the **Repair for the Maintenance of RoRo Berth at Babak Port, Island Garden City of Samal**. Completion of the Works is required to be within **Two Hundred Forty (240) Calendar Days**. Bidders must have an experience of having completed a **single contract that is similar to this Project** and whose value, adjusted to current price using the NSO consumer price indices, must be **at least fifty percent (50%) of the ABC**, as provided in the preceding paragraph. A detailed description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.

Bidding will be conducted through **open competitive bidding procedures** using **non-discretionary pass/fail criterion** as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from the **Philippine Ports Authority – Port Management Office of Davao** and inspect the Bidding Documents at its office at **(Old-PDO Building) Km. 10, Port Area, Sasa, Davao City** from **8:00 a.m. to 5:00 p.m., Monday to Friday**.

A complete set of Bidding Documents may be purchased from the date of this publication by interested Bidders at the Procuring Entity’s given address and upon payment of a non-refundable fee for the Bidding Documents in the amount of **Twenty Five Thousand Pesos (Php25,000.00)**.

It may also be downloaded free of charge from the website of the **Philippine Government Electronic Procurement System (PhilGEPS)** and at the website of the Procuring Entity, provided that bidders shall pay the fee for the Bidding Documents not later than the deadline for the submission of bids.

Bids must be delivered on or before (deadline for the submission and receipt of bids) **8:00 A.M., June 2, 2016 at the PPA Port Management Office of Davao (Old-PDO Building), Km. 10, Port Area, Sasa, Davao City**. All bids must be accompanied by a bid security in any of the following acceptable forms and amount:

Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below on **June 2, 2016 at 9:30 A.M.** Late bids shall not be accepted.

The Philippine Ports Authority – Port Management Office of Davao reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.

2. Demolition and Disposal of Affected Area
3. Excavation/Backfill and Disposal of Fill
4. Supply, Deliver and Compact Selected Fill
5. Supply, Spread and Compact Item 200
6. Supply, Spread and Compact Item 201
7. Supply and deliver 500 – 1,000 kgs/pc Underlayer Rocks and 50-100kgs/pc Core Rocks
8. Concreting of RoRo Ramp and Retaining Walls, Fender Block, Curb and Deflector (3,500psi)
9. Fabricate and Laying of Concrete Interlocking Blocks (3,500psi) with 3” Diameter Pipe Hole
10. Reinforcement for Ramp, Blocks and Retaining Walls



11. Concreting of Grouted Riprap
12. Reinforcement for Grouted Riprap Cover
13. Supply and Deliver Mooring Bollard Including Complete Accessories (Nuts, Bolts, Chains, Shackles, etc.)
14. Install Mooring Bollard with Including Complete Accessories (Nuts, Bolts, Chains, Shackles, etc.)
15. Supply and Deliver HV Type Fender (300mm x 600mm x 1500 (L))
16. Install HV Type Fender (300mm x 600mm x 1500 (L))
17. Supply and Install Geotextile Fiber
18. Construction Safety and Health Program (as required under Department order No. 13)
