

HARBOR PILOT VACANCY ANNOUNCEMENT

Position Title	One (1) HARBOR PILOT

Qualifications:

An applicant shall submit proofs/documents that he possesses the following qualifications:

- a. A Filipino citizen;
- b. Not more than fifty-five (55) years old at the time the vacancy is announced for filling:
- c. Of sound physical and mental condition and of good moral character;d. Holder of a Maritime Industry Authority (MARINA) license as Harbor Pilot for the particular pilotage district applied for. Where no examination has yet been conducted by MARINA in that particular pilotage district, the applicant must at least be a holder of a harbor license in any pilotage district.

Documentary Requirements: (in three (3) copies)

- 1. Application Letter together with a duly Sworn Information Sheet/Biodata;
- 2. Certificates from MARINA:
 - a. Master Mariner
 - b. Harbor Pilots License to practice in the pilotage district applied for
 - c. Pilot's Examination Rating in the pilotage district applied for
 - d. Filipino Seafarers' Registry of Certificate
 - e. Standards of Training Certification and Watchkeeping for Seafarers (STCW) Certificate(s)
 - f. Qualification Document Certificate (for Domestic Seafarer only)
- 3. Updated Master Mariner License
- 4. Employer's Certification of Services Rendered as Shipmaster (name of vessels, tonnage, ports of call and length/period of service thereon, including frequency of calls on the pilotage waters applied for)
- 5. Copies of Certificates of Training Courses attended, Positions/Qualifications and Commendations/Awards in the maritime/port service;
- 6. Current Physical and Mental Fitness Certificates from a government physician, and current Board of Marine Inquiry (BMI) Clearance to the effect that no case has been filed, pending and/or decided against the applicant;
- 7. If already a harbor pilot, a Certification from the Chief Pilot stating the length of service and pilotage districts/waters served, including vessels/tonnages handled as harbor pilot;
- 8. Copy of Seafarer's Identification and Record Book (SIRB) for services rendered as Shipmaster;
- 9. Other relevant information/documents that would support the application as harbor pilot.
