<b>Position</b>	<b>One (1) Harbor Pilot</b>
<b>Pilotage District</b>	<b>Masao</b>
<b>Qualifications</b>	<ol style="list-style-type: none"> <li>1) Must be a Filipino citizen;</li> <li>2) Not more than fifty-five (55) years old at the time the vacancy is announced for filling-up;</li> <li>3) Of sound physical and mental condition and good of moral character;</li> <li>4) Holder of a Maritime Industry Authority (MARINA) license as Harbor Pilot for the Masao Pilotage District.</li> </ol>
<b>Requirements</b>	<ol style="list-style-type: none"> <li>1) An application letter together with the duly sworn Personal Information Sheet/Biodata;</li> <li>2) Certificate as Master Mariner;</li> <li>3) Copy of the Pilot's examination rating and License/Certificate issued by MARINA to practice as harbor pilot in Masao Pilotage District;</li> <li>4) Employer's Certification of Services rendered as shipmaster (names of vessels, tonnages, ports of call and length / period of services thereon, including frequency of calls on the pilotage waters of Agusan del Norte;</li> <li>5) Copies of Certificates of Training Courses attended, Positions/Qualifications and Commendation/Awards in the Maritime port services;</li> <li>6) Current Physical and Mental Fitness Certificates from a government physician and has a current Board of Maritime Inquiry (BMI) Clearance to the effect that no case has been filed pending and or decided against the applicant;</li> <li>7) If already a Harbor Pilot, a Certification from the Chief Pilot stating the length of service and the pilotage district/waters served and in what previous appointments attached;</li> </ol>


