NOTE: Stevedoring on containerized cargo for non-self sustaining vessel is exclusive of equipment hire if quay/dock crane or any lifting is supplied and used by the contractor/ operator.

M. SPECIAL CHARGES

1. Shifting/Restoring of cargo within the same hatch. 150% of Basic Rate
2. Shifting from one hatch to another or from hold to dock/pier or barge and vice versa 200% of Basic Rate

N. OTHER CHARGES

1. RO-RO TERMINAL FEE
