**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE
PROCUREMENT OF IT RESOURCES (LOT 4 - LASER PRINTER WITH LAN)
BAC-PGCS-013-2019**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of IT Resources (Lot 4 - Laser Printers with LAN), in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 28 November 2019, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 649,000.00**;

WHEREAS, in response to the said advertisement, only Columbia Technologies, Inc. secured the Bid Documents;

WHEREAS, Columbia Technologies, Inc. submitted its letter of withdrawal from participating in the bidding, dated 19 December 2019, and the BAC, finding the reason to be meritorious, accepted its withdrawal from participating in the bidding;

WHEREAS, the BAC, after a motion duly made and properly seconded, declared the bidding for the Procurement of IT Resources (Lot 4 - Laser Printers with LAN), a failure, pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which provides to wit:

"35.1 The BAC shall declare the bidding a failure when:

a) No bids are received;

xxx xxx xxx."

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Procurement of IT Resources (Lot 4 - Laser Printers with LAN), be declared a "failure" pursuant to Section 35.1 (a) of the 2016 Revised IRR of R.A. 9184.
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.
