SUBJECT : **BAC RESOLUTION DECLARING FAILURE OF BIDDING FOR THE PROPOSED DREDGING OF SAN ANDRES PORT, SAN ANDRES, QUEZON PROVINCE**



This has reference to the Opening of Bids for the Proposed Dredging of San Andres Port, San Andres, Quezon Province, held on 19 January 2021 at 10:00 a.m. The bidding was declared by the BAC as "failure of bidding" considering that the lone bidder for the project, Harbor Star Shipping Services, Inc. did not submit its bid documents within the prescribed deadline for submission thereof. Pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which states that: "The BAC shall declare the bidding a failure when: xxx xxx a) No bids are received xxx xxx."

In view thereof, we are submitting herewith BAC Resolution No. 006-2021 Series of 2021, recommending that the bidding for the Proposed Dredging of San Andres Port, San Andres, Quezon Province, be declared a "failure" pursuant to Section 35.1 (a) of the 2016 Revised IRR of RA 9184 and to conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184, for consideration and approval of the General Manager as Head of the Procuring Entity.

**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE
PROPOSED DREDGING OF SAN ANDRES PORT,
SAN ANDRES, QUEZON PROVINCE
LFP BHL NO. 008-2020**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Proposed Dredging of San Andres Port, San Andres, Quezon Province, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 23 December 2020, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 24,255,232.75**;

WHEREAS, in response to the said advertisement, only Harbor Star Shipping Services, Inc. secured the Bid Documents in the amount of ₱ 25,000.00;

WHEREAS, the lone bidder, Harbor Star Shipping Services, Inc. did not submit its bid documents within the prescribed deadline for submission thereof on 19 January 2021;

WHEREAS, the BAC, after a motion duly made and properly seconded, declared the bidding for the Proposed Dredging of San Andres Port, San Andres, Quezon Province, a failure, pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which provides to wit:

“35.1 The BAC shall declare the bidding a failure when:

- a) No bids are received;

xxx xxx xxx.”

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Proposed Dredging of San Andres Port, San Andres, Quezon Province, be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184;
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.
