**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE
RENOVATION OF PPA HEAD OFFICE CANTEEN**
BAC-PGCS-080-2021
(Early Procurement)

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Renovation of PPA Head Office Canteen, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 11 February 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 5,621,628.57**;

WHEREAS, in response to the said advertisement, only Cytracon Corporation secured the Bid Documents and submitted the Technical and Financial Proposals in the amount of **₱ 10,000.00**;

WHEREAS, during the opening of bids on 04 March 2021 at 10:00 a.m., the lone bidder, Cytracon Corporation, was declared "failed" in the requirements of the First Envelope.

WHEREAS, Cytracon Corporation signified its intention to file a request for reconsideration, however, on even date, it submitted a letter manifesting that they will no longer request for a reconsideration and requested to withdraw their Financial Proposal for the project;

WHEREAS, in view of the letter submitted by Cytracon Corporation, its Second Envelope was returned unopened and duly received by its authorized representative;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Renovation of PPA Head Office Canteen, be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184;
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.
