**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE  
RECONSTRUCTION OF RC PIER & CONSTRUCTION OF RORO RAMP  
PORT OF CARMEN, SAN AGUSTIN, ROMBLON**  
LFP BGS No. 006-2019

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Reconstruction of RC Pier & Construction of RoRo Ramp, Port of Carmen, San Agustin, Romblon, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 20 March 2019, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be bid as posted/advertised is **₱ 44,084,950.00**;

WHEREAS, in response to the said advertisement, only D.K. Jocson Const. secured and submitted the Bid Documents in the amount of ₱ 25,000.00;

WHEREAS, during the opening of bids on 15 April 2019 at 2:00 p.m., D.K. Jocson Const. was automatically disqualified for failure to comply with the requirement of the Bid Data Sheet and pointed out in the Important Reminders for the Pre-Bid Conference that the Bid Proposals should be properly labeled, and with index tabs;

WHEREAS, the BAC, after a motion duly made and properly seconded, declared the bidding for the Reconstruction of RC Pier & Construction of RoRo Ramp, Port of Carmen, San Agustin, Romblon, a failure, pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which provides to wit:

“35.1 The BAC shall declare the bidding a failure when:

xxx xxx xxx

b) All prospective bidders are declared ineligible;

xxx xxx xxx.”

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Reconstruction of RC Pier & Construction of RoRo Ramp, Port of Carmen, San Agustin, Romblon, be declared a “failure” pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184;

2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.
