RESOLUTION DECLARING FAILURE OF BIDDING FOR THE PROCUREMENT OF FURNITURE & FIXTURES FOR CAGAYAN DE ORO PASSENGER TERMINAL BUILDING

BAC-PGCS-002-2019

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of Furniture & Fixtures for Cagayan de Oro Passenger Terminal Building, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 23 May 2019, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₽ 23,747,965.20**;

WHEREAS, in response to the said advertisement, two (2) bidders secured and submitted the Bid Documents in the amount of #25,000.00, namely:

- 1. Asahi Design Centre, Incorporated
- 2. Progress Home and Office Furnishings

WHEREAS, during the opening of bids on 14 June 2019 at 10:00 a.m., only Progress Home and Office Furnishings was declared "passing" with the requirements of the First Envelope. Asahi Design Centre, Inc. was automatically disqualified for failure to comply with the bid submission required under Section 20.3 of the Bid Date Sheet of the Bidding Documents which states that "All bid documents shall be book bound, hard bound and properly labelled with index tabs. xxx" The financial proposal of Asahi Design Center, Inc. has no index tabs;

WHEREAS, the Financial Proposal of Progress Home and Office Furnishings was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

HO-BAC-PGCS Res. No. 077-2019 Page 1 of 3 WHEREAS, Bid Evaluation was conducted on 21 June 2019 using non-discretionary criteria to determine the completeness of the bid and arithmetical corrections;

WHEREAS, the Bid-Evaluation Report, as approved by the BAC on 25 June 2019, showed non-compliance on the Technical Specifications particularly Items No. 10.1 (Nursing Station and Child Care), 11.2 (Inter-Faith Room) and 15.1 (Play Lot Area) of the Bid Proposal, hence Progress Home and Office Furnishings was declared "failed" for being non-responsive as the bid did not address or provide all of the required items in the Bidding Documents, pursuant to Section 32.2.1 (a) Rule IX of the 2016 Revised IRR of RA 9184;

WHEREAS, Progress Home and Office Furnishings filed a request for reconsideration on their "failed" rating, and the BAC, in a meeting held on 02 July 2019, after due deliberation, denied said request for reconsideration;

WHEREAS, in view of the foregoing, the bidding for the Procurement of Furniture & Fixtures for Cagayan de Oro Passenger Terminal Building, was hereby declared a "failure", pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which provides to wit:

"35.1 The BAC shall declare the bidding a failure when:

b) All prospective bidders are declared ineligible;

XXX XXX XXX."

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

- To recommend to the Head of the Procuring Entity that the bidding for the Procurement of Furniture & Fixtures for Cagayan de Oro Passenger Terminal Building, be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184.
- To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.

This has reference to the Opening of Bids for the Procurement of Furniture & Fixtures for Cagayan de Oro Passenger Terminal Building held on 14 June 2019, where the Single Calculated Bidder, Progress Home and Office Furnishings, was declared "failed" during the conduct of Bid Evaluation for being non-responsive as the bid did not address or provide all of the required items in the Bidding Documents, pursuant to Section 32.2.1 (a) Rule IX of the 2016 Revised IRR of RA 9184.

The BAC declared a failure of bidding pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which states that: "The BAC shall declare the bidding a failure when: xxx xxx b) All prospective bidders are declared ineligible. xxx xxx."

In view thereof, we are submitting herewith BAC Resolution No. 077-2019 Series of 2019 Declaring Failure of Bidding for the Procurement of Furniture & Fixtures for Cagayan de Oro Passenger Terminal Building and to conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184, for consideration and approval of the General Manager as Head of the Procuring Entity.
