FOR THE CONSULTANCY SERVICES FOR THE TECHNICAL SERVICES
FOR THE CONDUCT OF SOIL INVESTIGATION AT
SELECTED PORTS (PACKAGE 11)

WHEREAS, the Philippine Ports Authority (PPA) posted a Request for Expression of Interest for the Consultancy Services for the Technical Services for the Conduct of Soil Investigation at Selected Ports (Package 11), in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 17 July 2023, continuously for seven (7) calendar days;

WHEREAS, in response thereto, three (3) consulting firms secured and submitted the Eligibility Documents, namely:

1. R.S. Jardin & Associates
2. Solar Surveying Corporation
3. Gammacon Builders Inc./Universal Testing Laboratory and Inspection/JV

WHEREAS, after the Eligibility Screening conducted on 27 July 2023, R.S. Jardin & Associates, Solar Surveying Corporation and Gammacon Builders Inc./Universal Testing Laboratory and Inspection/JV were declared eligible to bid for the project.

WHEREAS, in BAC Resolution No. CON 009-2023 dated 28 July 2023, Recommending Shortlist of Consultants for the Consultancy Services for the Technical Services for the Conduct of Soil Investigation at Selected Ports (Package 11), R.S. Jardin & Associates, Solar Surveying Corporation and Gammacon Builders Inc./Universal Testing Laboratory and Inspection/JV were declared as shortlisted consultants, as approved by the Head of the Procuring Entity (HOPE);

WHEREAS, only two (2) consultants dropped their Technical and Financial Proposals before the deadline for the submission of bid documents on 31 August 2023. Gammacon Builders Inc./Universal Testing Laboratory and Inspection/JV submitted its letter of withdrawal, dated 30 August 2023, from participating in the bidding, and the BAC, finding the reasons to be meritorious, accepted its withdrawal from participating in the bidding;

WHEREAS during the opening of the Technical Proposals (First Envelope) held on 31 August 2023 at 2:00 p.m., R.S. Jardin & Associates and Solar Surveying Corporation were declared “passing” with the requirements of the First Envelope;

WHEREAS, after detailed evaluation of the Technical Proposals submitted by R.S. Jardin & Associates and Solar Surveying Corporation, using the criteria specified in the Bidding Documents, said evaluation resulted in the following:

WHEREAS, after the opening and evaluation by the BAC of the Financial Proposals (Second Envelope) of R.S. Jardin & Associates and Solar Surveying Corporation on 11 September 2023, the following total ratings, taking into consideration the technical and financial ratings, were arrived at, as follows:



This has reference to the Detailed Technical and Financial Evaluation Proposals Evaluation Results of R.S. Jardin & Associates for the Consultancy Services for the Technical Services for the Conduct of Soil Investigation at Selected Ports (Package 11). It is informed that the criteria used by the BAC-EP/CON in the detailed evaluation is 70% for the Technical Proposal and 30% for the Financial Proposal.

During the opening of the Technical Proposal (First Envelope), held on 31 August 2023, the shortlisted consultants, R.S. Jardin & Associates and Solar Surveying Corporation were both declared as "passed" with the requirements of the First Envelope. During the detailed evaluation of the Technical Proposals, R.S. Jardin obtained a rating of 89.37% while Solar Surveying Corporation obtained a rating of 71.26%. R.S. Jardin has a financial proposal in the amount of P30,694,383.70 with a rating of 19.05% and garnered a total rating of 90.55% while Solar Surveying Corporation with a financial proposal of P29,243,800.00 obtained a total rating of 77.01%. R.S. Jardin & Associates was identified by the BAC as the Highest Rated Bidder.

Pursuant to Section 33.4 of the Revised IRR of R.A. 9184 "the entire evaluation process, including the submission of the results thereof to the Head of the Procuring Entity, for approval, shall be completed in not more than twenty-one (21) calendar days after the deadline for the receipt of proposals. The proposal with the highest score shall be identified as the Highest Rated Bid."

In view thereof, we are submitting herewith, BAC-PGCS Resolution No. CON 010-2023 Series of 2023, for consideration and approval of the General Manager, as Head of the Procuring Entity,
