RESOLUTION DECLARING FAILURE OF BIDDING FOR THE PROPOSED RENOVATION OF PPA EXECUTIVE LOUNGE AND GYM, PPA CORPORATE BUILDING, SOUTH HARBOR, PORT AREA, MANILA LFP NCS NO. 033-2018

WHEREAS, the Philippine Ports Authority (PPA) advertised an Invitation to Bid for the Proposed Renovation of PPA Executive Lounge and Gym, PPA Corporate Building, South Harbor, Port Area, Manila, in the Manila Standard, a newspaper of general nationwide circulation on 12 September 2018 and posted the same in the website of the PPA, PhilGEPS and at a conspicuous place in the PPA premises, continuously for seven (7) calendar days;

WHEREAS, no prospective bidders responded to the said advertisement, nor secured the bid documents;

WHEREAS, the BAC, after a motion duly made and properly seconded, declared the bidding for the Proposed Renovation of PPA Executive Lounge and Gym, PPA Corporate Building, South Harbor, Port Area, Manila, a failure, pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which provides to wit:

“35.1 The BAC shall declare the bidding a failure when:

a) No bids are received;

xxx xxx xxx.”

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Proposed Renovation of PPA Executive Lounge and Gym, PPA Corporate Building, South Harbor, Port Area, Manila, be declared a “failure” pursuant to Section 35.1 (a) of the 2016 Revised IRR of R.A. 9184.
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.
