BAC Resolution Declaring Failure of Bidding

RESOLUTION NO. 46A s. 2019

WHEREAS, the PPA PMO Northern Luzon as procuring entity, advertised the Invitation to Bid for the project REPAIR OF DAMAGED PORT FACILITIES DAMAGED BY TYPHOON OMPONG, PORT CLAVERIA, CAGAYAN, posted at the Phil-GEPS and PPA websites and at the PPA, PMO Northern Luzon bulletin board continuously for seven (7) days;

WHEREAS, only one (1) bid proposal was submitted on October 18, 2019 at 1:00PM by M.C. TORIO CONSTRUCTION;

WHEREAS, upon post-qualification and perusal, validation and verification of the eligibility, technical and financial requirements submitted, M. C. TORIO's bid proposal was found to be the Single Lowest Calculated and Responsive Bid;

WHEREAS, on October 28, 2019 and October 30, 2019 the Notice of Post-Qualification and Notice of Award were respectively furnished to M.C. TORIO CONSTRUCTION;

WHEREAS, on November 12, 2019 M.C. TORIO CONSTRUCTION refused to accept the Notice of Award due to change in physical condition of the project site and facilities brought by the onslaught of Typhoon Quiel and the flooding of the town of Claveria, Cagayan;

Whereas on November 13, 2019 the BAC Chairman and the TWG with the assistance of the Engineering Services Division (ESD) were enjoined by the HOPE to verify the Contractor's allegations, conduct a site inspection and submit a report on the matter;


Whereas on November 18, 2019 the TWG and ESD submitted a verified report confirming that the reasons cited by the Contractor were justifiable and recommended for the revision of the terms., conditions, and specifications, and if necessary, adjust the ABC, subject to the required approvals, and conduct a re-bidding with re-advertisement and/or posting in accordance with the revised IRR of RA 9184;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVED to recommend a FAILURE OF BIDDING for the REPAIR OF DAMAGED PORT FACILITIES DAMAGED BY TYPHOON OMPONG, PORT OF CLAVERIA, CAGAYAN.
