50	Requirements for this project and encouraged the bidder to ask questions on concerns that need further		
51	clarification. Since the prospective bidder is categorized under sole proprietorship, the required forms will		
52	fall under form 3. The Vice-Chairperson further mentioned of the licenses required and the PhilGEPS		

53 registration which requires "platinum", the bidder need not to submit a copy of Mayor's Permit until Post-54 Qualification. For forms 4 to 7, the bidder should indicate "Not Applicable" but not to leave a blank or 55 they will be disqualified. The bidder must ensure to attach the Project Completion and Acceptance of their 56 previous projects and Sworn Statement must be duly notarized.
