BAC RESOLUTION NO. 004-2021

A Resolution declaring the bid of Khan Kon Chi Construction and Development Corporation as the Lowest Calculated bid for the project "Repair of Old, Dilapidated RC Pier at port of Lipata, Culasi, Antique"

WHEREAS, opening of bids for the above project with Approved Budget for the Contract to be Bid (ABC) of ***Twenty-Seven Million Nine Hundred Forty-Three Thousand Two Hundred Thirty-Six Pesos and 66/100(P 27,943, 236.66)*** was conducted at the Conference Room, 2nd Floor- PPA Administration Building, Iloilo Commercial Port Complex, Iloilo City and virtually via zoom on January 12, 2021 at ten o' clock in the morning;

WHEREAS, the nine (9) contractors purchased the bid documents, namely:

- EC Structural Composites Inc.
- Khan Kon Chi Construction and Development Corporation
- J.S. Layson & Co., Inc.
- F. Gurrea Construction Inc.
- AD Pendon Construction & Supply, Inc.
- Noe's Builders
- Abelarde Builders and Supply
- MG Salazar Construction Corporation
- EG Garcia Construction

WHEREAS, MG Salazar Construction Corporation withdrew from participating in the bidding due to the following reasons: forgot to include the lacking documents, statement of on-going project and statement of single largest complete contract related to the project;

WHEREAS, EG Garcia Construction submitted bids beyond the time set for submission, hence, declared "LATE";

WHEREAS, five (5) contractors were evaluated non-compliant after checking their submitted proposal; two (2) contractors were declared compliant:

- EC Structural Composites Inc.
- Khan Kon Chi Construction and Development Corporation


WHEREAS, evaluation of the bids tendered by the eligible bidders revealed that Khan Kon Chi Construction and Development Corporation has the lowest calculated bid, which is lower than the ABC by 0.79%;

- EC Structural Composites Inc.- P27,923,236.66
- Khan Kon Chi Construction and Development Corporation- P 27,723,564.47




