The Pre-Bid Conference for the above projects held at 2nd Floor PPA Conference, Admin Building, 2nd Floor, ICPC, Iloilo City was called to Order at 10:00 in the morning of July 31, 2020 and was simultaneously telecast via zoom considering that mass gathering is prohibited due to the current pandemic.

BAC Chairman requested the Secretariat to apprise the body of the schedule pre-bid conference. The BAC Secretariat read first the pre-bidding brief and acknowledges the attendance of BAC Members and Bidders present and likewise the reading of the previous minutes for approval of the BAC. Thru the motion of Vice Chair Belarga, duly seconded by BAC member Bunda, minutes of the pre-procurement meeting was approved. Likewise, as presented by the Secretariat the BAC was in quorum base in the attendance.

Observers from COA, PGII, PICE and CBCP were all invited per letter dated 10 July 2020; however, none attended.

The Head of the Secretariat informed the body that posting of ITB of the project “Garbage Collection and Disposal at Baseport, CY 2020” has been made in PhilGeps, PPA WEB and PPA Bulletin - July 24-30, 2020.
