AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT ROUTINE MAINTENANCE OF PORT PHYSICAL FACILITIES PROJECT 2023 PACKAGE 1: (1) REPAINTING OF GI CHAINS, SHACKLES AND ACCESSORIES AT RORO AND NEWLY CONSTRUCTED WHARF AND REPAINTING OF BOLLARDS ALONG CAL.000-851; (2) REPAIR OF SETTLED PAVING BLOCKS AT CY1 & CY; (3) REPAIR OF CHB PERIMETER FENCE AT HOLCIM AREA, PORT OF GENERAL SANTOS, MAKAR WHARF, GENERAL SANTOS CITY”

WHEREAS, The Philippine Ports Authority (PPA), PMO SOCSARGEN posted/published the Invitation to Bid for the project “ROUTINE MAINTENANCE OF PORT PHYSICAL FACILITIES PROJECT 2023 PACKAGE 1: (1) REPAINTING OF GI CHAINS, SHACKLES AND ACCESSORIES AT RORO AND NEWLY CONSTRUCTED WHARF AND REPAINTING OF BOLLARDS ALONG CAL.000-851; (2) REPAIR OF SETTLED PAVING BLOCKS AT CY1 & CY; (3) REPAIR OF CHB PERIMETER FENCE AT HOLCIM AREA, PORT OF GENERAL SANTOS, MAKAR WHARF, GENERAL SANTOS CITY” with an Approved Budget for the Contract (ABC) of **Nine Hundred Twelve Thousand Seven Hundred Seventy-Nine Pesos and 95/100 Only (Php912,779.95) Inclusive of 5% VAT**;

WHEREAS, in Resolution No. 11 Series of 2023, the BAC declared Winch Mechanical Innovations and General Construction, Inc. as Single Calculated Bidder with a Calculated Bid at Php819,008.93 inclusive of 5% VAT;

WHEREAS, on May 29, 2023, the Technical Working Group (TWG) conducted the Post-Qualification in accordance with Rule X of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184;

WHEREAS, during Post-Qualification, the legal, technical, and financial documents under technical and financial components of the bid of Winch Mechanical Innovations, were verified, validated, and ascertained

WHEREAS, on May 30, 2023, the result of Post-Qualification was reported as having passed all the criteria of Post-Qualification and recommended by the TWG for the declaration of Single Calculated Responsive Bidder;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVED** as it is hereby **RESOLVED**:


