## SIX (6) LOTS –SUPPLY AND DELIVERY OF VARIOUS OFFICE MATERIALS, SUPPLIES, EQUIPMENT, AND LABOR AND MATERIALS FOR THE FABRICATION AND PRINTING OF T-SHIRTS OF PPA, PMO-ZAMBOANGA

## BAC Resolution Declaring the Lowest Calculated and Responsive Quotation, Failure of Bidding and Recommending Approval

RESOLUTION NO. 17 - 2015

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga through its Bids and Awards Committee for the Procurement of Goods and Services (BAC-PG) in accordance with Section 52.1 (b)-Shopping and Section 53.9-Negotiated Procurement-Small Value Procurement of the Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 advertised/posted the Request for Quotation for the Six (6) Lots - Supply and Delivery of Various Office Materials, Supplies, Equipment, and Labor and Materials for the Fabrication and Printing of T-Shirts of PPA, PMO-Zamboanga in the PPA Website, PhilGEPS Website, and a conspicuous place at the Bulletin Board of PPA, PMO-Zamboanga from December 3-10, 2015, continuously for seven (7) calendar days;

WHEREAS, from December 3-10, 2015, the Office required the suppliers to submit not later than December 11, 2015 at 2:00 P.M. their quotations enclosed in an envelope with the following documents:

- a) Duly accomplished PPA-Prequalification State Form together with the attached documents;
   and
  - 1. Valid Current Mayor's Business Permit;
  - 2. Certificate of Registration of Business Name (DTI/SEC or CDA);
  - 3. BIR-VAT/Non-VAT Registration Certificate;
  - 4. Latest Annual Income Tax Return (Annual Income Tax Return-CY 2014); and
  - 5. Certificate of Philgeps Registration.
- b) Duly accomplished Bidder's Tender Form with price quotations indicated therein (sealed separately).

WHEREAS, the Office required that suppliers should have the complete documents attached to the Bidder's Tender Form sealed separately in an envelope and quotations received in excess of the ABC shall be automatically rejected. It was also stated that the said lot shall be awarded to the supplier determined to have submitted the complete documents and with lowest calculated and responsive quotation;

WHEREAS, the Members of the BAC-PG together with the Technical Working Group (TWG), the Secretariat, and GSO/Concurrent Procurement Officer, and COA Representative attended the meeting during the Opening of Quotations held on December 11, 2015 at 2:00 P.M., at the Conference Room, Administrative Building, PPA, PMO-Zamboanga;

WHEREAS, the Chairperson of the BAC-PG, Emiliano M. Esparaguera, Jr., presided over the meeting and announced the Opening of Quotations of the following:

## A. Mode of Procurement-Shopping

- One (1) Lot Supply and Delivery of Various Office Furniture and Equipment, Brand New (ABC=PhP 227,000.00);
- One (1) Lot Supply and Delivery of Four (4) Units Air Conditioner, 2HP, Window Type, Remote Model (ABC=PhP 160,000.00);

- One (1) Lot Supply and Delivery of Two (2) Units Television and One (1) Unit Digital Camera, Brand New (ABC=PhP 165,000.00);
- One (1) Lot Supply and Delivery of Various Supplies and Materials per PR# 2015-205 (ABC=PhP 150,000.00);
- B. Mode of Procurement Negotiated Procurement Small Value Procurement
  - One (1) Lot Supply of Labor and Materials for the Fabrication and Printing of T-Shirts (PhP 80,000.00); and
  - 6) One (1) Lot Supply and Delivery on Site of Materials, Labor, and Equipment for the Provision of Three (3) Units Bases and Six (6) Units Handheld Radios, Brand New, Including its Installation at PPA, Ports of Isabela, Ipil and Pagadian (ABC=PhP 210,000.00).

WHEREAS, the Chairperson requested the TWG to open the bid documents submitted by the suppliers item by item and the BAC members evaluated the following:

For Item No. 1, there were five (5) suppliers that were given the bid documents, namely: 1)
 Zamboanga City LM Enterprises; 2) National Commercial; 3) ZC Paperline and Computer Stationers; 4) EMCOR, Inc.-Veterans Branch; and 5) RC Lim Marketing;

Among the five (5) suppliers, only two (2) suppliers submitted their bid documents. Since under RA 9184 at least three (3) price quotations must be obtained and only two (2) price quotations were obtained, the BAC members declared the bidding a failure for Item No. 1;

The BAC members agreed not to open the two (2) price quotations and instead extend the schedule of the opening of bids from December 11 to December 23, 2015 at 2:00 PM, Conference Room, PPA, PMO-Zamboanga, by re-inviting more suppliers in order to obtain at least three (3) eligible suppliers.

2. For Item No. 2, there were five (5) suppliers that were given the bid documents, namely: 1) Silicon Valley Zamboanga; 2) Zamboanga City LM Enterprises; 3) National Commercial; 4) RC Lim Marketing; and 5) Emcor, Inc.- Veterans Branch. All of them submitted their bid documents with the following price quotations:

Although, Silicon Valley Computer Group Phils., Inc. is the lowest calculated bidder, however, the LG, Model-LA200RC is not in accordance with the specifications required by the Office and was determined non-compliant.

After validation of the documents of Emcor, Inc. - Veterans Branch as the second lowest calculated bidder, the said supplier was found responsive. The BAC members agreed to recommend Emcor, Inc. - Veterans Branch as the bidder with the lowest calculated and responsive quotation in the amount of P 113,980.00;

3. For Item No. 3, there were four (4) suppliers that were given the bid documents, namely: 1) Zamboanga City LM Enterprises; 2) National Commercial; 3) RC Lim Marketing; and 4) Emcor, Inc.- Veterans Branch;

Among the four (4) suppliers, only three (3) suppliers submitted their bid documents with the following price quotations:

Although, RC Lim Marketing is the lowest calculated bidder, however, the LG, Model-43LF5710 for two (2) units Television is not in accordance with the specifications required by the Office and was determined non-compliant.

After validation of the documents of Zamboanga City LM Enterprises as the second lowest calculated bidder, the said supplier was found responsive. The BAC members agreed to recommend Zamboanga City LM Enterprises as the bidder with the lowest calculated and responsive quotation in the amount of P 153,940.00;

4. For Item No. 4, there were four (4) suppliers that were given the bid documents, namely: 1) Victorious General Merchandise and Services; 2) Zamboanga Goodwill Hardware; 3) Asiatic Trading Corporation; and 4) Dennis Hardware Enterprises. All of them submitted their bid documents with the following price quotations:

After validation of the documents of Asiatic Trading Corporation as the lowest calculated bidder, the said supplier was found responsive. The BAC members agreed to recommend Asiatic Trading Corporation as the bidder with the lowest calculated and responsive quotation in the amount of P114,434.00;

5. For Item No. 5, there were three (3) suppliers that were given the bid documents, namely: 1) Zapparel Enterprises; 2) Decocrafters Gallery; and 3) Fit and Style Garments. All of them submitted their bid documents with the following price quotations:

After validation of the documents of Fit and Style Garments as the lowest calculated bidder, the said supplier was found responsive. The BAC members agreed to recommend Fit and Style Garments as the bidder with lowest calculated and responsive quotation in the amount of PhP66.045.00;

For Item No. 6, there were three (3) suppliers that were given the bid documents, namely: 1)
Electron Comtronics and Service Center; 2) Sapro Electronics; and 3) Phone Patch Marketing.

Among the three (3) suppliers, only Electron Comtronics and Service Center submitted the bid documents with the price quotation in the amount of PhP 210,000.00.

After validation of the documents of Electron Comtronics and Service Center, the said supplier was found responsive. The BAC members agreed to recommend Electron Comtronics and Service Center as the bidder with lowest calculated and responsive quotation in the amount of PhP210,000.00;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby, RESOLVE, as it is hereby RESOLVED:

- a) To declare Item No. 1 One (1) Lot Supply and Delivery of Various Office Furniture and Equipment, Brand New, failure of bidding and extend the schedule of opening of bids from December 11 to December 23, 2015;
- b) To declare the following suppliers as the suppliers with the Lowest Calculated and Responsive Quotation:
  - Lemcor, Inc. Veterans Branch in the amount of PhP 113,980.00 for Item No. 2 One (1) Lot Supply and Delivery of Four (4) Units Air Conditioner, 2HP, Window Type, Remote Model;

  - Asiatic Trading Corporation in the amount of PhP 114,434.00 for Item No. 4 One (1) Lot Supply and Delivery of Various Supplies and Materials;
  - 4. Fit and Style Garments in the amount of PhP 66,045.00 for Item No. 5 One (1) Lot Supply of Labor and Materials for the Fabrication and Printing of the T-Shirts; and
- Electron Comtronics and Service Center in the amount of PhP 210,000.00 for Item No. 6 –
  Supply and Delivery on Site of Materials, Labor, and Equipment for the Provision of Three
  (3) Units Bases and Six (6) Units Handheld Radios, Brand new, Including its Installation at
  PPA, Ports of Isabela, Ipil, and Pagadian;
- c) To recommend for approval by the Port Manager of PPA, PMO-Zamboanga the foregoing findings.
