BAC Resolution Declaring Single Calculated and Responsive Bid and Recommending Approval

WHEREAS, the Philippine Ports Authority, PMO-Zamboanga advertised/posted the Invitation to Submit Proposal for the One (1) Lot Supply, Delivery, and Installation of Eleven (11) Units Air Conditioning Units (ACUs) and Eleven (11) Units Door Air Curtain Units, All Brand New, at the Traveler's Hub, Philippine Ports Authority, PMO-Zamboanga, at the Philippine Government Electronic Procurement System (PhilGEPS) Website, PPA Website and conspicuous place at the premises of the Philippine Ports Authority, PMO-Zamboanga continuously for 7 days on December 29, 2015 to January 5, 2016;

WHEREAS, in response to the said advertisements, only one (1) supplier, Emtor, Incorporated-Veterans, Veterans Avenue, Camino Nuevo, Zamboanga City, manifested its interest to participate in the Negotiated Procurement under Section 53.1-Two Failed Biddings of the Revised Implementing Rules and Regulations of Republic Act (RA) 9184;
