"A RESOLUTION DECLARING A.I. YU BUILDERS AND ENTERPRISES AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT PROPOSED PWD RAMPS AT MAIN GATE AREA, HARBOR AREA AND IN FRONT OF FORMER PPD OFFICE; WALKWAY GUARD RAIL ALONG MAIN GATE AREA TO POWERHOUSE AREA AND HARBOR AREA; AND REPAINTING OF THE WALKWAY SHED FROM MAIN GATE TO POWERHOUSE AREA, HARBOR AREA AND IN FRONT OF ADMIN. BUILDING, PORT OF GENERAL SANTOS, MAKAR WHARF, GENERAL SANTOS CITY"

WHEREAS, THE Philippine Ports Authority (PPA), PMO SOCSARGEN posted/published the Invitation to Bid for the project Proposed PWD Ramps at Main Gate Area, Harbor Area and In Front of Former PPD Office; Walkway Guard Rail Along Main Gate Area to Powerhouse Area and Harbor Area; and Repainting of the Walkway Shed from Main Gate to Powerhouse Area, Harbor Area and In Front of Admin. Building, Port of General Santos, Makar Wharf, General Santos City with an Approved Budget for the Contract (ABC) of **Four Million Twenty Nine Thousand Five Hundred Fifty Six and 57/100 Pesos Only (P 4,029,556.57)** only;

WHEREAS, the said Invitation to Bid was posted at the PhilGEPS, PPA Websites and at the PMO SOCSARGEN's Bulletin Board;

WHEREAS, in response to the said publication and posting requirement, one (1) bidder procured the bidding documents namely A.I. Yu Builders and Enterprises;

WHEREAS, the bidder successfully dropped its bid on time;

WHEREAS, the TWG, during the December 28, 2015 meeting of the BAC-EP, reported its validation and confirmation of the legal, technical and financial requirements submitted by A.I. Yu Builders and Enterprises;

NOW, THEREFORE, We the members of the Bids and Awards Committee, hereby **RESOLVED** as it is **RESOLVED**:



- b) To recommend to the Head of the Procuring Entity for the approval of the said findings and issuance of the Notice of Award.


