WHEREAS, the Financial Proposal of the two (2) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, post-qualification was conducted from 10 - 22 February 2021 to examine, validate and verify the eligibility, technical and financial requirements submitted by Premium Megastructures Inc. and in the Post-Qualification Report, as approved by the BAC on 23 March 2021, Premium Megastructures Inc. was declared as the Lowest Calculated and Responsive Bidder;
