WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Proposed Construction and Offshore Installation of Aids to Marine Navigation at Ports of Iloilo and Dumangas, Iloilo Province, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 16 November 2018, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 233,053,710.68**;

WHEREAS, in response to the said advertisement, only Dalebo Const. & Gen. Merchandise/Jarzoe Builders, Inc./JV secured and submitted the Bid Documents in the amount of ₱ 50,000.00;

WHEREAS, during the opening of bids on 07 December 2018 at 10:00 a.m., Dalebo Const. & Gen. Merchandise/Jarzoe Builders, Inc./JV was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Dalebo Const. & Gen. Merchandise/Jarzoe Builders, Inc./JV was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

Merchandise/Jarzoe Builders, Inc./JV was declared as the Single Calculated and Responsive Bidder;
