WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply and Delivery of Utility Jackets, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 16 November 2020, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 10,000,000.00**;

WHEREAS, in response to the said advertisement, two (2) bidders secured the Bid Documents and submitted the Technical and Financial Proposals in the amount of ₱ 10,000.00, namely:

1. Zhujar Manufacturing, Inc.
2. Dante's Executive Menswear & Bag's Accessories

WHEREAS, during the opening of bids on 09 December 2020 at 10:00 a.m., Dante's Executive Menswear & Bag's Accessories was declared "passing" with the requirements of the First Envelope. Zhujar Manufacturing, Inc. was declared "automatically disqualified" for submitting its technical documents which were not book-bound and hard bound, as required under Item 15 of Bid Data Sheet, which provides that "All bid documents shall be book-bound, hard-bound and properly labeled with index tabs".

WHEREAS, the Second Envelope of Zhujar Manufacturing, Inc. was returned unopened and duly received by its authorized representative;

WHEREAS, the Financial Proposal of Dante's Executive Menswear & Bag's Accessories was opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 11 December 2020 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 14 December 2020, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Dante's Executive Menswear & Bag's Accessories;

WHEREAS, Dante's Executive Menswear & Bag's Accessories was declared as the Single Calculated Bidder in the amount of ₱ 9,610,500.00;


WHEREAS, post-qualification was conducted on 18 December 2020 to examine, validate and verify the eligibility, technical and financial requirements submitted by Dante's Executive Menswear & Bag's Accessories and in the Post-Qualification Report, as approved by the BAC on 22 December 2020, Dante's Executive Menswear & Bag's Accessories was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **DANTE'S EXECUTIVE MENSWEAR & BAG'S ACCESSORIES** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Supply and Delivery of Utility Jackets, in the amount of **NINE MILLION SIX HUNDRED TEN THOUSAND FIVE HUNDRED PESOS (PHP 9,610,500.00)**, inclusive of taxes, to the said bidder.
