WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply and Delivery of Utility Vests, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 25 November 2020, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 3,000,000.00**;

WHEREAS, in response to the said advertisement, only Dante's Executive Menswear & Bag's Accessories secured the Bid Documents and submitted the Technical and Financial Proposals;

WHEREAS, during the opening of bids on 16 December 2020 at 10:30 a.m., Dante's Executive Menswear & Bag's Accessories was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Dante's Executive Menswear & Bag's Accessories was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Dante's Executive Menswear & Bag's Accessories was declared as the Single Calculated Bidder in the amount of **₱ 3,000,000.00**;

WHEREAS, post-qualification was conducted on 23 December 2020 to examine, validate and verify the eligibility, technical and financial requirements submitted by Dante's Executive Menswear & Bag's Accessories and in the Post-Qualification Report, as approved by the BAC on 29 December 2020, Dante's Executive Menswear & Bag's Accessories was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **DANTE'S EXECUTIVE MENSWEAR & BAG'S ACCESSORIES** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Supply and Delivery of Utility Vests, in the amount of **THREE MILLION PESOS (₱ 3,000,000.00)**, inclusive of taxes, to the said bidder.
