**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE  
CONSTRUCTION OF CAUSEWAY WITH STAIRLANDINGS,  
PORT OF TAJUJURA, BASCO, BATANES  
PPA-DOTR NO. 014-2018**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Construction of Causeway with Stairlandings, Port of Tadjura, Basco, Batanes (DOTR Project downloaded to PPA for implementation), in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 06 December 2018, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be bid as posted/advertised is **₱ 19,146,146.33**;

WHEREAS, in response to the said advertisement, only Actuate Builders, Inc. secured the Bid Documents;

WHEREAS, Actuate Builders, Inc. did not submit their bid documents before the deadline for Submission of Bids at 9:00 a.m. on 04 January 2019 nor did they submit a letter of withdrawal from participating in the bidding before the deadline for submission of bids;

WHEREAS, the BAC, after a motion duly made and properly seconded, declared the bidding for the Construction of Causeway with Stairlandings, Port of Tadjura, Basco, Batanes, a failure, pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which provides to wit:

"35.1 The BAC shall declare the bidding a failure when:

a) No bids are received;

xxx xxx xxx."

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Construction of Causeway with Stairlandings, Port of Tadjura, Basco, Batanes, be declared a "failure" pursuant to Section 35.1 (a) of the 2016 Revised IRR of R.A. 9184.
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.

This has reference to the Bidding for the Design, Supply and Installation of VRF-HVAC Systems and Generator Units for the Passenger Terminal Building, Port of Cagayan de Oro, Misamis Oriental; Lubang Port Development Project, Port of Lubang, Brgy. Tilik, Lubang, Occidental Mindoro; Construction of Causeway with Stairlandings, Port of Tajujura, Basco, Batanes; Excavation, Extension of Breakwater and Construction of Boat Mooring Facilities, Port of Sabtang, Batanes; Buenavista Port Development Project, Port of Buenavista, Bohol, held on 03 and 04 January 2019, which was declared by the BAC as "failure of bidding" pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which states that: "The BAC shall declare the bidding a failure when: a) No bids are received; b) All prospective bidders are declared ineligible; xxx xxx."

In view thereof, we are submitting herewith BAC Resolution Nos. 001-2019, 002-2019, 003-2019, 2004-2009 and 2005-2019 recommending that the bidding for the Design, Supply and Installation of VRF-HVAC Systems and Generator Units for the Passenger Terminal Building, Port of Cagayan de Oro, Misamis Oriental; Lubang Port Development Project, Port of Lubang, Brgy. Tilik, Lubang, Occidental Mindoro; Construction of Causeway with Stairlandings, Port of Tajujura, Basco, Batanes; Excavation, Extension of Breakwater and Construction of Boat Mooring Facilities, Port of Sabtang, Batanes; Buenavista Port Development Project, Port of Buenavista, Bohol, be declared a "failure" and to conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184, for consideration and approval of the General Manager as Head of the Procuring Entity.
