PORT TERMINAL MANAGEMENT CONTRACT FOR THE CLUSTERED PORTS OF BENONI, BALBAGON AND GUINSILIBAN

BAC-PTMC-04-2023

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the PTMC for Clustered Ports of Benoni, Balbagon and Guinsiliban in newspaper of general circulation, PPA website and in conspicuous places in the PPA premises on 09 November 2023:

WHEREAS, the Minimum Concession Fee for the fifteen (15) year PTMC as posted is Php 269,912,843.24;

WHEREAS, in response to the said advertisement, Balbagon Arrastre Stevedoring and Porterage Services, Inc. (BASPS) secured the Bid Documents in the amount of Php 100,000.00;

WHEREAS, during the Opening of Bids on 04 November 2023 at 10:00 a.m., the BASPS was declared "passed" with the requirements of the First Envelope;

WHEREAS, BASPS' Second Envelope was opened and its Proposed Concession Fee was read as follows:
