**PORT TERMINAL MANAGEMENT CONTRACT FOR THE CLUSTERED PORTS  
OF BENONI, BALBAGON AND GUINSILIBAN  
BAC-PTMC-04-2023**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the PTMC for Clustered Ports of Benoni, Balbagon and Guinsiliban in newspaper of general circulation, PPA website and in conspicuous places in the PPA premises on 09 November 2023;

WHEREAS, the Minimum Concession Fee for the fifteen (15) year PTMC as posted is Php 269,912,843.24;

WHEREAS, in response to the said advertisement, Balbagon Arrastre Stevedoring and Portage Services, Inc. (BASPS) secured the Bid Documents in the amount of Php 100,000.00;

WHEREAS, during the Opening of Bids on 04 November 2023 at 10:00 a.m., the BASPS was declared "passed" with the requirements of the First Envelope;

WHEREAS, BASPS' Second Envelope was opened and its Proposed Concession Fee was read as follows:

WHEREAS, Bid Evaluation was conducted to determine compliance with the requirements of PPA Administrative Order (AO) No. 12-2018; and the Bid Evaluation Report was approved by the BAC-PTMC on 11 December 2023, declaring BASPS at its Proposed Concession Fee of Two Hundred Seventy Two Million Five Hundred One Thousand Nine Hundred Eighty Pesos (Php 272,501,980.00) exclusive of all taxes as the Bidder with the Highest Concession Fee;

WHEREAS, Post-Qualification was conducted on 14 December 2023 to determine compliance with all the requirements, terms and conditions for eligibility and

the bidding; and in the Post-Qualification Report, as approved by the BAC-PTMC on 18 December 2023, the proposal of BASPS was declared as the Highest Responsive Bid;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC-PTMC hereby RESOLVE, as it is hereby RESOLVED, to declare BASPS at its Proposed Concession Fee of Two Hundred Seventy Two Million Five Hundred One Thousand Nine Hundred Eighty Pesos (Php 272,501,980.00) exclusive of all taxes, as the Highest Responsive Bidder and to recommend the award of Port Terminal Management Contract for the Clustered Ports of Balbagon, Benoni and Guinsiliban.
