WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Jose Panganiban Port Improvement Project, Port of Jose Panganiban, Brgy. Osmeña, Jose Panganiban, Camarines Norte, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 25 November 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P 544,925,203.40**;

WHEREAS, in response to the said advertisement, ten (10) bidders secured the Bid Documents in the amount of ₱ 75,000.00, namely:

- 1. Khan Kon Chi Construction and Development Corp.
- 2. Luzviminda Engineering
- 3. Sunwest. Inc.
- 4. MAC Builders
- WTG Construction and Development Corp.
- 6. MRBII Construction Corporation
- 7. Vicente T. Lao Construction
- Goldridge Construction & Development Corp.
- 9. Bemkar Construction & Supply
- 10. F. Gurrea Construction Inc.

WHEREAS, only nine (9) bidders dropped their Technical and Financial Proposals before the prescribed deadline for submission. F. Gurrea Construction Inc. did not submit their Technical and Financial Proposals nor submitted a letter of withdrawal from participating in the bidding before the prescribed deadline for submission of bid documents:

WHEREAS, during the opening of bids on 20 December 2023 at 2:00 p.m., the nine (9) bidders were declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposals of the nine (9) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 22 December 2023 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 28 December 2023, showed discrepancies between the Total Bid Prices and Unit Bid Prices of Sunwest, Inc., WTG Construction and Development Corp. and Luzviminda Engineering, as follows;

WHEREAS, MRBII Construction Corporation was declared as the Lowest Calculated Bidder in the amount of ₱ 543,387,448.60;

WHEREAS, post-qualification was conducted on 05 January 2024 to examine, validate and verify the eligibility, technical and financial requirements submitted by MRBII Construction Corporation and in the Post-Qualification Report, as approved by the BAC on 11 January 2024, MRBII Construction Corporation was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED, to declare **MRBII CONSTRUCTION CORPORATION** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Jose Panganiban Port Improvement Project, Port of Jose Panganiban, Brgy. Osmeña, Jose Panganiban, Camarines Norte, in the amount of **FIVE HUNDRED FORTY THREE MILLION THREE HUNDRED EIGHTY SEVEN THOUSAND FOUR HUNDRED FORTY EIGHT PESOS AND 60/100 (₱ 543,387,448.60)**, inclusive of taxes, to the said bidder.
