## Award of Contract for the CONSTRUCTION OF PORT OPERATIONAL AREA WITH CONTINUOUS RORO RAMP AND FASTCRAFT BERTH, PORT OF GETAFE, BOHOL LFP BHL NO. 033-2021

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Construction of Port Operational Area with Continuous RoRo Ramp and Fastcraft Berth, Port of Getafe, Bohol, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 03 November 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **P 465,079,912.22**;

WHEREAS, in response to the said advertisement, four (4) bidders secured the Bid Documents in the amount of ₱ 50,000.00, namely:

- MAC Builders
- 2. WTG Construction and Development Corporation
- 3. Sunwest Construction and Development Corporation
- 4. F. Gurrea Construction Inc.

WHEREAS, during the opening of bids on 24 November 2021 at 10:00 a.m., the four (4) bidders were declared "passing" with the requirements of the First Envelope.

WHEREAS, the Financial Proposal of the four (4) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 01 December 2021 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 02 December 2021, showed discrepancies between the Total Bid Prices and Unit Bid Prices of WTG Construction and Development Corp., Sunwest Construction and Development Corp. and F. Gurrea Construction Inc., as follows:

WHEREAS, MAC Builders was declared as the Lowest Calculated Bidder in the amount of ₱ 458,987,999.98;

WHEREAS, post-qualification was conducted on 06 & 09 December 2021 to examine, validate and verify the eligibility, technical and financial requirements submitted by MAC Builders and in the Post-Qualification Report, as approved by the BAC on 28 December 2021, MAC Builders was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **MAC BUILDERS** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Construction of Port Operational Area with Continuous RoRo Ramp and Fastcraft Berth, Port of Getafe, Bohol, in the amount of **FOUR HUNDRED FIFTY EIGHT MILLION NINE HUNDRED EIGHTY SEVEN THOUSAND NINE HUNDRED NINETY NINE PESOS AND 98/100 (P 458,987,999.98), inclusive of taxes, to the said bidder.**
