This has reference to the Opening of Bids for the Procurement of Pest Control Services for PPA Head Office, Motorpool, PPATI, GAD Center and Records Storage Facility held on 10 January 2023. The bidding was declared a failure by the BAC pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which states that: "The BAC shall declare the bidding a failure when: xxx xxx a) All prospective bidders are declared ineligible. xxx xxx."

In view thereof, we are submitting herewith BAC Resolution No. 001-2023 Series of 2023 Declaring Failure of Bidding for the Procurement of Pest Control Services for PPA Head Office, Motorpool, PPATI, GAD Center and Records Storage Facility and to conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184, for consideration and approval of the General Manager as Head of the Procuring Entity.

**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE
PROCUREMENT OF PEST CONTROL SERVICES FOR PPA HEAD OFFICE,
MOTORPOOL, PPATI, GAD CENTER AND RECORDS STORAGE FACILITY
BAC-PGCS-067-2022**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement of Pest Control Services for PPA Head Office, Motorpool, PPATI, GAD Center and Records Storage Facility, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 12 December 2022, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 2,470,000.00**;

WHEREAS, in response to the said advertisement, only Pest Away Corporation secured the Bid Document in the amount of **₱ 5,000.00** and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 10 January 2023 at 2:00 p.m., the lone bidder, Pest Away Corporation was declared "failed" with the requirements of the First Envelope, for the following reasons:

- a) The Mayor's Permit in the Class "A" Eligibility Documents which was an integral part of the Certificate of PhilGEPs Registration expired on June 30, 2022. The Class "A" Eligibility Documents should remain valid and updated as required in the Certificate of PhilGEPs Registration and GPPB Resolution No. 15-2021.
- b) The submitted date of Contract for the Statement of the Bidder's Single Largest Completed Contract (SLCC) similar to the contract to be bid was July 01, 2020 to June 30, 2021 and the date of delivery was July 01, 2020. However, the submitted Contract and Certification of Completion was for years 2017 - 2018 and 2019 - 2020, respectively.
- c) The Statement Compliance in the Technical Specifications was not supported by literature (brochure) as required in the Technical Documents.
- d) Non-submission of any proof that the bidder is in the business continuously for the past five (5) years, or more and has successfully undertaken similar treatments in at least three (3) agencies/companies.
- e) Non-submission of a Certification issued by three (3) clients attesting to the services rendered during the last five (5) years.

WHEREAS, Pest Away Corporation signified no intention to file a request for reconsideration;

WHEREAS, considering that the lone bidder was declared "failed", the BAC, after a motion duly made and properly seconded, declared the bidding for the Procurement of Pest Control Services for PPA Head Office, Motorpool, PPATI, GAD Center and Records Storage Facility, a failure, pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184, which provides, that:

"35.1 The BAC shall declare the bidding a failure when:

xxx xxx xxx

b) All prospective bidders are declared ineligible;

xxx xxx xxx."

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Procurement of Pest Control Services for PPA Head Office, Motorpool, PPATI, GAD Center and Records Storage Facility, be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A 9184.
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.


