## Award of Contract for the BULADO PORT EXPANSION PROJECT, PORT OF BULADO, BRGY. BULADO, GUIHULNGAN, NEGROS ORIENTAL

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Bulado Port Expansion Project, Port of Bulado, Brgy. Bulado, Guihulngan, Negros Oriental, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 25 November 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is ₱ 285,591,854.79;

WHEREAS, in response to the said advertisement, nine (9) bidders secured the Bid Documents in the amount of ₱ 50,000.00 and submitted their Technical and Financial Proposals, namely:

WHEREAS, during the opening of bids on 20 December 2023 at 10:30 a.m., the nine (9) bidders were declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposals of the nine (9) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

Tan Construction Corp./JV, Luzviminda Engineering and Sunwest, Inc., as follows;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED, to declare WTG CONSTRUCTION AND DEVELOPMENT CORP. as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Bulado Port Expansion Project, Port of Bulado, Brgy. Bulado, Guihulngan, Negros Oriental, in the amount of TWO HUNDRED SEVENTY THREE MILLION ONE HUNDRED TWENTY THREE THOUSAND ONE HUNDRED NINETY SEVEN PESOS AND 22/100 (₱ 273,123,197.22), inclusive of taxes, to the said bidder.
