Award of Contract for the  
**RESTORATION OF PORT FACILITIES DAMAGED BY TYPHOON "TISOY"**  
**PORT OF CLAVERIA, BURIAS ISLAND, MASBATE**  
*HO-INFRA-PPDD-23-0074*

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Restoration of Port Facilities Damaged by Typhoon "Tisoy" Port of Claveria, Burias Island, Masbate, in the websites of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 17 November 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 16,517,665.76**;

WHEREAS, in response to the said advertisement, three (3) bidders secured the Bid Documents in the amount of ₱25,000.00 and submitted their Technical and Financial Proposals, namely:

1. ZET Construction
2. Algimar Construction Corporation
3. NBCDC Corporation

WHEREAS, during the opening of bids on 13 December 2023 at 9:00 a.m., only NBCDC Corporation was declared "passing" with the requirements of the First Envelope. ZET Construction and Algimar Construction Corporation were declared "failed" with the requirements of the Technical Proposal, for the following reasons:

ZET Construction:

- a. Failed to meet the required Experience Record for the Rockworks and Construction of Building. The required weight of rocks was 50-2000 kg/pc, what was submitted was 50-1000 kg/pc. The required area for construction of the building was 355 sq.m., what was submitted was 253 sq.m.
- b. Submitted an expired Certification of Accreditation issued by the Department of Public Works and Highways (DPWH) for the pledged Materials Engineer.
- c. Failed to submit proof of ownership for the pledged one (1) unit Concrete Cutter. What was submitted was Delivery Receipt, which is not an acceptable proof of ownership.

**THOUSAND SIX HUNDRED THIRTEEN PESOS AND 05/100 (Php 16,350,613.05),**  
inclusive of taxes, to the said bidder.



Algimar Construction Corporation:

- a. Failed to meet the required work experience for Rockworks and Construction of Building. There was no indicated weight per piece of the rocks in the submitted supporting documents. Likewise, no Recapitulation and/or Final Bill of Quantities for the Construction of Building to verify the actual area.
- b. Failed to meet the minimum requirement for work experience similar in nature and complexity to the project to be bid for the pledged Project Manager, Project Engineer and Foreman.

WHEREAS, Algimar Construction Corporation signified its intention to file a request for reconsideration, hence, the unopened Second Envelope was retained by the BAC, until the request for reconsideration has been resolved by the Committee;

WHEREAS, the Financial Proposal of NBCDC Corporation was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Algimar Construction Corporation did not file a request for reconsideration within the prescribed deadline for filing thereof;

WHEREAS, Bid Evaluation was conducted on 18 December 2023 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 20 December 2023, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of NBCDC Corporation;


WHEREAS, NBCDC Corporation was declared as the Single Calculated Bidder in the amount of ₱ 16,350,613.05;

WHEREAS, post-qualification was conducted on 04 January 2024 to examine, validate and verify the eligibility, technical and financial requirements submitted by NBCDC Corporation and in the Post-Qualification Report, as approved by the BAC on 08 January 2024, NBCDC Corporation was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED, to declare **NBCDC CORPORATION** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Restoration of Port Facilities Damaged by Typhoon "Tisoy" Port of Claveria, Burias Island, Masbate, in the amount of **SIXTEEN MILLION THREE HUNDRED FIFTY THOUSAND SIX HUNDRED THIRTEEN PESOS AND 05/100 (Php 16,350,613.05)**, inclusive of taxes, to the said bidder.
