Award of Contract for the
**CONSTRUCTION OF PCG-PPA K-9 ACADEMY, SITIO BANA,
BRGY. DOLORES, CLARK SPECIAL ECONOMIC ZONE, PAMPANGA**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Construction of PCG-PPA K-9 Academy, Sitio Bana, Brgy. Dolores, Clark Special Economic Zone, Pampanga, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 18 November 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 94,796,949.45**;

WHEREAS, in response to the said advertisement, two (2) bidders secured the Bid Documents in the amount of **₱ 50,000.00**, namely:

1. E.U. Jingco Construction Corp./ Big J Steel Construction Corp./JV
2. Reed Steel Fabricators, Inc.

WHEREAS, only E.U. Jingco Construction Corp./ Big J Steel Construction Corp./JV dropped its Technical and Financial Proposals on the scheduled date of the opening of bids. Reed Steel Fabricators, Inc. did not submit its Technical and Financial Proposals, however, on the same date at 2:56 p.m., Reed Steel Fabricators, Inc. sent an e-mail informing the BAC that they will not submit their bid documents due to unavailability of some equipment;

WHEREAS, during the opening of bids on 15 December 2021 at 2:00 p.m., E.U. Jingco Construction Corp./ Big J Steel Construction Corp./JV was declared "passing" with the requirements of the First Envelope.

WHEREAS, the Financial Proposal of E.U. Jingco Construction Corp./ Big J Steel Construction Corp./JV was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 21 December 2021 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 22 December 2021, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of E.U. Jingco Construction Corp./ Big J Steel Construction Corp./JV;


WHEREAS, E.U. Jingco Construction Corp./ Big J Steel Construction Corp./JV was declared as the Single Calculated Bidder in the amount of ₱ 92,886,092.73;

WHEREAS, post-qualification was conducted on 27 & 29 December 2021 to examine, validate and verify the eligibility, technical and financial requirements submitted by E.U. Jingco Construction Corp./ Big J Steel Construction Corp./JV and in the Post-Qualification Report, as approved by the BAC on 13 January 2021, E.U. Jingco Construction Corp./ Big J Steel Construction Corp./JV was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **E.U. JINGCO CONSTRUCTION CORP./ BIG J STEEL CONSTRUCTION CORP./JV** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Construction of PCG-PPA K-9 Academy, Sitio Bana, Brgy. Dolores, Clark Special Economic Zone, Pampanga, in the amount of **NINETY TWO MILLION EIGHT HUNDRED EIGHTY SIX THOUSAND NINETY TWO PESOS AND 73/100 (₱ 92,886,092.73)**, inclusive of taxes, to the said bidder.


