## Award of Contract for the ALEGRIA PORT DEVELOPMENT PROJECT, PORT OF ALEGRIA BURUANGA, AKLAN LFP PNG NO. 036-2019

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Alegria Port Development Project, Port of Alegria, Buruanga, Aklan, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 14 November 2019, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **217,619,862.09**;

WHEREAS, in response to the said advertisement, five (5) bidders secured the Bid Documents in the amount of  $\stackrel{\square}{=}$  50,000.00, namely:

- 1. Sunwest Construction & Development Corporation
- 2. IBC International Builders Corporation
- 3. F. Gurrea Construction, Incorporated
- 4. Hi-Tone Construction & Development Corporation
- 5. MRBII Construction Corporation

WHEREAS, only four (4) bidders dropped their Technical and Financial Proposals in the bid boxes located at the BAC Office, 5<sup>th</sup> Floor, PPA Building, namely: F. Gurrea Const., Inc.; Sunwest Const. & Dev't. Corp; IBC Int'l Builders Corp. and Hi-Tone Const. & Dev't. Corp. MRBII Const. Corp. submitted its letter of withdrawal from participating in the bidding, dated 10 December 2019, and the BAC, finding the reason of MRBII Const. Corp. to be meritorious, accepted its withdrawal from participating in the bidding;

WHEREAS, during the opening of bids on 10 December 2019 at 2:00 p.m., only three (3) bidders were declared "passing" with the requirements of the First Envelope, namely: Sunwest Const. & Dev't. Corp.; IBC Int'l Builders Corp. and F. Gurrea Const., Inc. Hi-Tone Const. & Dev't. Corp. was declared "failed" hence, its Second Envelope was retained by the BAC considering that there was no representative who signified the intention to file a request for reconsideration. However, no request for reconsideration was filed by Hi-Tone Const. & Dev't. Corp. within the prescribed deadline for filing thereof;

WHEREAS, Bid Evaluation was conducted on 16 December 2019 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 17 December 2019, showed discrepancies between the Total Bid Prices and Unit Bid Prices of the following bidders;

WHEREAS, post-qualification was conducted on 06 January 2020 to examine, validate and verify the eligibility, technical and financial requirements submitted by IBC Int'l Builders Corp. and in the Post-Qualification Report, as approved by the BAC on 10 January 2020, IBC Int'l Builders Corp. was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare IBC INTERNATIONAL BUILDERS CORPORATION as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Alegria Port Development Project, Port of Alegria, Buruanga, Aklan, in the amount of TWO HUNDRED FOURTEEN MILLION EIGHT HUNDRED FIFTY THOUSAND PESOS (#214,850,000.00), inclusive of taxes. to the said bidder.
