CLOUD-BASED UNIFIED ELECTRONIC TICKETING CAPABILITIES FOR THE  
PHILIPPINE PORTS AUTHORITY**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply, Delivery, Installation and Commissioning of Electronic Terminal Management System (ETMS) Inclusive of Cloud-Based Unified Electronic Ticketing Capabilities for the Philippine Ports Authority, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 17 September 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 500,000,000.00**;

WHEREAS, in response to the said advertisement, two (2) bidders secured the Bid Documents in the amount of ₱50,000.00 and submitted their Technical and Financial Proposals, namely;

1. NEXTIX Inc./Carus Ferry AB Ltd./JV
2. Omniprime Marketing, Inc./Willoglen Services Pte. Ltd./NSS IT Solution Sdn. Bhd./JV

WHEREAS, during the opening of bids on 12 October 2021 at 10:00 a.m., the two (2) bidders were declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of the two (2) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

2. NEXTIX INC./CARUS FERRY AB LTD./JV	₱ 499,898,347.00



WHEREAS, Bid Evaluation was conducted on 18 October 2021 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 19 October 2021, showed no discrepancies between the Total Bid Prices and Unit Bid Prices. However deviations were found in the Bid Proposals of NEXTIX Inc./Carus Ferry AB Ltd./JV and Omniprime Marketing, Inc./Willoglen Services Pte. Ltd./NSS IT Solution Sdn. Bhd./JV, particularly on their respective Single Largest Completed Contract (SLCC), hence both bidders were declared “failed” for failure to comply with the requirements of the SLCC, which must be similar to the contract to be bid;

WHEREAS, NEXTIX Inc./Carus Ferry AB Ltd./JV and Omniprime Marketing, Inc./Willoglen Services Pte. Ltd./NSS IT Solution Sdn. Bhd./JV filed their respective requests for reconsideration on their “failed” rating, however, the BAC, in a meeting held on 23 November 2021, denied the Request for Reconsideration of Omniprime Marketing, Inc./Willoglen Services Pte. Ltd./NSS IT Solution Sdn. Bhd./JV while the Request for Reconsideration of NEXTIX Inc./Carus Ferry AB Ltd./JV was granted by the Committee;

WHEREAS, NEXTIX Inc./Carus Ferry AB Ltd./JV was declared as the Single Calculated Bidder in the amount of ₱ 499,898,347.00;

WHEREAS, post-qualification was conducted on 03 December 2021 to examine, validate and verify the eligibility, technical and financial requirements submitted by NEXTIX Inc./Carus Ferry AB Ltd./JV and in the Post-Qualification Report, as approved by the BAC on 15 December 2021, NEXTIX Inc./Carus Ferry AB Ltd./JV was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **NEXTIX INC./CARUS FERRY AB LTD./JV** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Supply, Delivery, Installation and Commissioning of Electronic Terminal Management System (ETMS) Inclusive of Cloud-Based Unified Electronic Ticketing Capabilities for the Philippine Ports Authority, in the amount of **FOUR HUNDRED NINETY NINE MILLION EIGHT HUNDRED NINETY EIGHT THOUSAND THREE HUNDRED FORTY SEVEN PESOS (PHP 499,898,347.00)**, inclusive of taxes, to the said bidder.


