Award of Contract for the
RESTORATION OF DAMAGED QUAY 2 (BERTH 2),
PORT OF ZAMBOANGA, ZAMBOANGA CITY
HO-INFRA-PPDD-23-0081

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Restoration of Damaged Quay 2 (Berth 2), Port of Zamboanga, Zamboanga City, in the websites of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 21 November 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 29,581,498.25**;

WHEREAS, in response to the said advertisement, two (2) bidders secured the Bid Documents in the amount of ₱25,000.00 and submitted their Technical and Financial Proposals, namely:

1. ZET Construction
2. Majda Construction & Development

WHEREAS, during the opening of bids on 12 December 2023 at 3:00 p.m., only Majda Construction & Development was declared “passing” with the requirements of the First Envelope. ZET Construction was declared “failed” with the requirements of the Technical Proposal, for the following reasons:

- a. Failed to meet the required Experience Record for the Reinforcement of Steel Bars. What was submitted was 79,634.64 kgs. instead of 83,160.89 kgs.
- b. Submitted an expired Accreditation Identification Card issued by the Department of Public Works and Highways (DPWH) for the pledged Materials Engineer.
- c. Failed to submit LTO OR/CR for the pledged one (1) unit Water Truck (leased).

WHEREAS, ZET Construction signified no intention to file their request for reconsideration on their “failed” rating, hence, their Second Envelope was returned unopened and duly received by their authorized representative;

WHEREAS, the Financial Proposal of Majda Construction & Development was opened and declared “passing” with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 18 December 2023 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 20 December 2023, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Majda Construction & Development;

WHEREAS, Majda Construction & Development was declared as the Single Calculated Bidder in the amount of ₱ 29,425,204.44;

WHEREAS, post-qualification was conducted on 06 January 2024 to examine, validate and verify the eligibility, technical and financial requirements submitted by Majda Construction & Development and in the Post-Qualification Report, as approved by the BAC on 08 January 2024, Majda Construction & Development was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED, to declare **MAJDA CONSTRUCTION & DEVELOPMENT** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Restoration of Damaged Quay 2 (Berth 2), Port of Zamboanga, Zamboanga City, in the amount of **TWENTY NINE MILLION FOUR HUNDRED TWENTY FIVE THOUSAND TWO HUNDRED FOUR PESOS AND 44/100 (Php 29,425,204.44)**, inclusive of taxes, to the said bidder.
