WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply and Delivery of Janitorial and COVID-19 Sanitation Supplies, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 02 December 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 10,000,000.00**;

WHEREAS, in response to the said advertisement, only Alert General Services Corporation secured the Bid Document in the amount of ₱ 10,000.00 and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 23 December 2021 at 10:00 a.m., Alert General Services Corporation was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Alert General Services Corporation was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 24 December 2021 to determine if there were arithmetical or computational errors on the submitted financial proposal of Alert General Services Corporation, and the Bid Evaluation Report, as approved by the BAC on 27 December 2021, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Alert General Services Corporation;


WHEREAS, Alert General Services Corporation was declared as the Single Calculated Bidder in the amount of ₱ 9,998,655.30;

WHEREAS, post-qualification was conducted on 28 December 2021 to examine, validate and verify the eligibility, technical and financial requirements submitted by Alert General Services Corporation and in the Post-Qualification Report, as approved by the BAC on 13 January 2022, Alert General Services Corporation was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **ALERT GENERAL SERVICES CORPORATION** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Supply and Delivery of Janitorial and COVID-19 Sanitation Supplies, in the amount of **NINE MILLION NINE HUNDRED NINETY EIGHT THOUSAND SIX HUNDRED FIFTY FIVE PESOS AND 30/100 (PHP 9,998,655.30)**, inclusive of taxes, to the said bidder.


