**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE
LEASE AND MAINTENANCE OF PHOTOCOPIING MACHINES
BAC-PGCS-129-2022**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Lease and Maintenance of Photocopying Machines, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 12 December 2022, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 2,160,000.00**;

WHEREAS, in response to the said advertisement, only Copylandia Office Systems Corp. secured the Bid Document in the amount of **₱ 5,000.00** and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 10 January 2023 at 10:00 a.m., the lone bidder, Copylandia Office Systems Corp. was declared "failed" with the requirements of the First Envelope (Technical Component), for failure to submit an updated PhilGEPs Certificate of Platinum Registration and Membership. The Mayor's Permit in the Class "A" Eligibility Documents which was an integral part of the PhilGEPs Certificate of Platinum Registration and Membership expired on December 31, 2022. The Class "A" Eligibility Documents should remain valid and updated as required in the PhilGEPs Certificate of Platinum Registration and Membership and GPPB Resolution No. 15-2021.

WHEREAS, on 13 January 2023, Copylandia Office Systems Corp. filed a request for reconsideration on their "failed" rating, however, the BAC, in a meeting held on 19 January 2023, after due deliberation and upon motion duly made and properly seconded, denied said Request for Reconsideration;

WHEREAS, considering that the lone bidder was declared "failed", the BAC, after a motion duly made and properly seconded, declared the bidding for the Lease and Maintenance of Photocopying Machines, a failure, pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184, which provides, that:

"35.1 The BAC shall declare the bidding a failure when:

xxx xxx xxx

b) All prospective bidders are declared ineligible;


xxx xxx xxx."

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Lease and Maintenance of Photocopying Machines, be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184.
2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.



This has reference to the Opening of Bids for the Lease and Maintenance of Photocopying Machines on 10 January 2023, which was declared by the BAC as "failure of bidding," pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which states that: "The BAC shall declare the bidding a failure when: xxx xxx xxx b) All prospective bidders are declared ineligible; xxx xxx xxx." In view thereof, we are submitting herewith BAC-PGCS Resolution No. 003-2023 Series of 2023, recommending that the bidding for the above project be declared a "failure" pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184 and to conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184, for consideration and approval of the General Manager as Head of the Procuring Entity.
