RESOLUTION DECLARING FAILURE OF BIDDING FOR THE PROCUREMENT FOR THE SUPPLY, DELIVERY AND ASSEMBLY OF TWENTY TWO (22) UNITS OF MOBILE SHOWER ROOMS FOR THE PORT MANAGEMENT OFFICES BAC-PGCS-018-2019

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Procurement for the Supply, Delivery and Assembly of Twenty Two (22) Units of Mobile Shower Rooms for the Port Management Offices, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 23 December 2019, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 15,000,000.00**;

WHEREAS, no prospective bidders responded to the said Invitation to Bid, nor secured the bid documents;

WHEREAS, the BAC, after a motion duly made and properly seconded, declared the bidding for the Procurement for the Supply, Delivery and Assembly of Twenty Two (22) Units of Mobile Shower Rooms for the Port Management Offices, a failure, pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which provides to wit:

“35.1 The BAC shall declare the bidding a failure when:

a) No bids are received;

xxx xxx xxx.”

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Procurement for the Supply, Delivery and Assembly of Twenty Two (22) Units of Mobile Shower Rooms for the Port Management Offices, be declared a “failure” pursuant to Section 35.1 (a) of the 2016 Revised IRR of R.A. 9184.

2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.
