**RESOLUTION DECLARING FAILURE OF BIDDING FOR THE  
MAINTENANCE SERVICES FOR ENTERPRISE STORAGE  
ARRAY AND RELATED EQUIPMENT**  
BAC-PGCS-247-2019

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Maintenance Services for Enterprise Storage Array and Related Equipment, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 16 December 2019, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 3,200,000.00**;

WHEREAS, in response to the said advertisement, only Infostorage Corporation secured and submitted the Bid Documents in the amount of ₱ 5,000.00;

WHEREAS, during the opening of bids on 20 January 2020 at 10:00 a.m., Infostorage Corporation, the lone bidder, was declared "failed" in the requirements of the First Envelope, for failure to attach the valid Mayor's Permit and Tax Clearance Certificate. The Second Envelope of Infostorage Corporation was returned unopened and duly received by its authorized representative after signifying no intention to file a request for reconsideration;

WHEREAS, the BAC, after a motion duly made and properly seconded, declared the bidding for the Maintenance Services for Enterprise Storage Array and Related Equipment, a failure, pursuant to Section 35.1 of the 2016 Revised IRR of R.A. 9184, which provides to wit:

"35.1 The BAC shall declare the bidding a failure when:

b) All prospective bidders are declared ineligible;

xxx xxx xxx."

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to recommend the following:

1. To recommend to the Head of the Procuring Entity that the bidding for the Maintenance Services for Enterprise Storage Array and Related Equipment, be declared a "failure" pursuant to Section 35.1 (b) of the 2016 Revised IRR of R.A. 9184;

2. To conduct a re-bidding with re-advertisement and/ or posting, as provided for in Section 21.2 of the 2016 Revised IRR of R.A. 9184.
