WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Design, Supply, Rehabilitation and Upgrade of Data Center Facility, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 06 December 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 65,000,000.00**;

WHEREAS, in response to the said advertisement, only Neo-Tech Asia Distribution, Inc. secured the Bid Document in the amount of **₱ 50,000.00** and submitted its Technical and Financial Proposals;

WHEREAS, during the opening of bids on 27 December 2021 at 2:00 p.m., Neo-Tech Asia Distribution, Inc. was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Neo-Tech Asia Distribution, Inc. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 03 January 2022 to determine if there were arithmetical or computational errors on the submitted financial proposal of Neo-Tech Asia Distribution, Inc., and the Bid Evaluation Report, as approved by the BAC on 04 January 2022, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Neo-Tech Asia Distribution, Inc.;

WHEREAS, Neo-Tech Asia Distribution, Inc. was declared as the Single Calculated Bidder in the amount of ₱ 64,900,000.00;

WHEREAS, post-qualification was conducted on 18 January 2022 to examine, validate and verify the eligibility, technical and financial requirements submitted by Neo-Tech Asia Distribution, Inc. and in the Post-Qualification Report, as approved by the BAC on 25 January 2022, Neo-Tech Asia Distribution, Inc. was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **NEO-TECH ASIA DISTRIBUTION, INC.** as the Single Calculated and Responsive Bidder, and to recommend the award of contract for the Design, Supply, Rehabilitation and Upgrade of Data Center Facility, in the amount of **SIXTY FOUR MILLION NINE HUNDRED THOUSAND PESOS (PHP 64,900,00.00)**, inclusive of taxes, to the said bidder.


