WHEREAS Columbia Technologies, Inc. was declared as the Single Calculated Bidder in the amount of **₱ 4,964,400.00**;

WHEREAS, post-qualification was conducted on 08 January 2020 to examine, validate and verify the eligibility, technical and financial requirements submitted by Columbia Technologies, Inc. and in the Post-Qualification Report, as approved by the BAC on 17 January 2020, Columbia Technologies, Inc. was declared as the Single Calculated and Responsive Bidder;


