Award of Contract for the
**CONSTRUCTION AND INSTALLATION OF SEWAGE TREATMENT PLANT,
VARIOUS PPA-PMO'S/TMO'S**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Construction and Installation of Sewage Treatment Plant, Various PPA-PMO's/TMO's, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 13 December 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 243,885,622.02**;

WHEREAS, in response to the said advertisement, three (3) bidders secured the Bid Documents in the amount of ₱ 50,000.00, namely:

1. Rudhil Construction & Enterprises, Inc.
2. Trass Construction Co., Inc.
3. Kael Construction Supply

WHEREAS, only Rudhil Construction & Enterprises, Inc. dropped its Technical and Financial Proposals before the deadline for the submission of bid documents on 17 January 2024. Trass Construction Co., Inc. submitted its letter of withdrawal from participating in the bidding, dated 17 January 2024, before the prescribed deadline for submission thereof, and the BAC, finding the reasons to be meritorious, accepted its withdrawal from participating in the bidding. Kael Construction Supply did not submit their Technical and Financial Proposals, nor submitted a letter of withdrawal from participating in the bidding before the prescribed deadline for submission of bid documents;

WHEREAS, during the opening of bids on 17 January 2024 at 9:00 a.m., the lone bidder, Rudhil Construction & Enterprises, Inc. was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Rudhil Construction & Enterprises, Inc. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 17 January 2024 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 18 January 2024, showed discrepancies between the Total Bid Prices and Unit Bid Prices of Rudhil Construction & Enterprises, Inc.;

WHEREAS, Rudhil Construction & Enterprises, Inc. was declared as the Single Calculated Bidder in the amount of ₱ 243,700,215.08;

WHEREAS, post-qualification was conducted on 20 to 22 January 2024 to examine, validate and verify the eligibility, technical and financial requirements submitted by Rudhil Construction & Enterprises, Inc. and in the Post-Qualification Report, as approved by the BAC on 24 January 2024, Rudhil Construction & Enterprises, Inc. was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare, **RUDHIL CONSTRUCTION & ENTERPRISES, INC.** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Construction and Installation of Sewage Treatment Plant, Various PPA-PMO's/TMO's, in the amount of **TWO HUNDRED FORTY THREE MILLION SEVEN HUNDRED THOUSAND TWO HUNDRED FIFTEEN PESOS AND 08/100 (₱ 243,700,215.08)**, inclusive of taxes, to the said bidder.
