Award of Contract for the CONSTRUCTION OF PASSENGER TERMINAL BUILDING, PORT OF CATAGBACAN, BOHOL LEP BHL NO. 039-2017

WHEREAS, the Philippine Ports Authority (PPA) advertised an Invitation to Bid for the Construction of Passenger Terminal Building, Port of Catagbacan, Bohol, in the Manila Standard, a newspaper of general nationwide circulation on 14 December 2018 and posted the same in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as published/advertised is **₽ 14,610,723.57**;

WHEREAS, in response to the said advertisement, only JFAP Const. secured and submitted the Bid Documents in the amount of ₽ 25,000.00;

WHEREAS, during the opening of bids on 10 January 2018 at 11:00 a.m., JFAP Const. was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of JFAP Const. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, post-qualification was conducted on 22 January 2018 to examine, validate and verify the eligibility, technical and financial requirements submitted by JFAP Const. and in the Post-Qualification Report, as approved by the BAC on 24 January 2018, JFAP Const. was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **JFAP CONSTRUCTION** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Construction of Passenger Terminal Building, Port of Catagbacan, Bohol, in the amount of **FOURTEEN MILLION FOUR HUNDRED SIXTY FIVE THOUSAND FIVE HUNDRED NINETY EIGHT AND 41/100 PESOS (P 14,465,598.41), inclusive of taxes, to the said bidder.**
