WHEREAS, the Philippine Ports Authority (PPA) advertised an Invitation to Bid for the Construction of Passenger Terminal Building, Port of Tagbilaran, Bohol, in the Manila Standard, a newspaper of general nationwide circulation on 14 December 2017 and posted the same in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as published/advertised is **₱ 70,414,112.12**;

WHEREAS, in response to the said advertisement, only Rex E. Morales Const. secured and submitted the Bid Documents in the amount of **₱ 50,000.00**;

WHEREAS, during the opening of bids on 10 January 2018 at 10:00 a.m., Rex E. Morales Const. was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Rex E. Morales Const. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:



MORALES CONSTRUCTION** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Construction of Passenger Terminal Building, Port of Tagbilaran, Bohol, in the amount of **SIXTY EIGHT MILLION NINE HUNDRED EIGHTY EIGHT THOUSAND TWO HUNDRED SIXTY FOUR AND 86/100 PESOS (₱ 68,988,264.86)**, inclusive of taxes, to the said bidder.


