### **Award of Contract for the CONSTRUCTION OF PORT OPERATIONAL AREA, PORT OF CURRIMAO, ILOCOS NORTE LFP NLZ NO. 039-2021**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Construction of Port Operational Area, Port of Currimao, Ilocos Norte, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 21 December 2021, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 154,885,070.97**;

WHEREAS, in response to the said advertisement, three (3) bidders secured the Bid Documents in the amount of **₱ 50,000.00** and submitted their Technical and Financial Proposals, namely:

1. Sunwest Construction and Development Corporation
2. Khan Kon Chi Construction and Development Corporation
3. MAC Builders

WHEREAS, during the opening of bids on 18 January 2022 at 10:00 a.m., the three (3) bidders were declared "passing" with the requirements of the First Envelope.

WHEREAS, the Financial Proposals of the three (3) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 24 January 2022 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 25 January 2022, showed discrepancies between the Total Bid Prices and Unit Bid Prices of Sunwest Construction and Development Corp., as follows:

WHEREAS, Khan Kon Chi Construction and Development Corporation was declared as the Lowest Calculated Bidder in the amount of ₱ 152,602,461.11;

WHEREAS, post-qualification was conducted on 28-29 January 2022 to examine, validate and verify the eligibility, technical and financial requirements submitted by Khan Kon Chi Construction and Development Corporation and in the Post-Qualification Report, as approved by the BAC on 03 February 2022, Khan Kon Chi Construction and Development Corporation was declared as the Lowest Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **KHAN KON CHI CONSTRUCTION AND DEVELOPMENT CORPORATION** as the Lowest Calculated and Responsive Bidder and to recommend the award of contract for the Construction of Port Operational Area, Port of Currimao, Ilocos Norte, in the amount of **ONE HUNDRED FIFTY TWO MILLION SIX HUNDRED TWO THOUSAND FOUR HUNDRED SIXTY ONE PESOS AND 11/100 (₱ 152,602,461.11)**, inclusive of taxes, to the said bidder.
