WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Supply, Delivery, Installation and Commissioning of HR Server, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 09 December 2020, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 14,000,000.00**;

WHEREAS, in response to the said advertisement, only Benz-Cy Enterprises, Inc. secured the Bid Documents in the amount of Php 25,000.00 and submitted the Technical and Financial Proposals;

WHEREAS, during the opening of bids on 07 January 2021 at 10:00 a.m., Benz-Cy Enterprises, Inc. was declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of Benz-Cy Enterprises, Inc. was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Bid Evaluation was conducted on 12 January 2021 to determine if there were arithmetical or computational errors on the submitted bid, and the Bid Evaluation Report, as approved by the BAC on 22 December 2020, showed no discrepancies between the Total Bid Prices and Unit Bid Prices of Benz-Cy Enterprises, Inc.;

WHEREAS, Benz-Cy Enterprises, Inc. was declared as the Single Calculated Bidder in the amount of ₱ 13,980,000.00;

WHEREAS, post-qualification was conducted on 19 January 2021 to examine, validate and verify the eligibility, technical and financial requirements submitted by Benz-Cy Enterprises, Inc. and in the Post-Qualification Report, as approved by the BAC on 21 January 2021, Benz-Cy Enterprises, Inc. was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED to declare **BENZ-CY ENTERPRISES, INC.** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Supply, Delivery, Installation and Commissioning of HR Server, in the amount of **THIRTEEN MILLION NINE HUNDRED EIGHTY THOUSAND PESOS (₱ 13,980,000.00)**, inclusive of taxes, to the said bidder.


