Award of Contract for the
**RESTORATION OF PASSENGER'S ADMINISTRATIVE AND PORT OPERATIONS
FACILITIES DAMAGED BY TYPHOON ODETTIE, PORT OF SURIGAO,
SURIGAO CITY, SURIGAO DEL NORTE**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Restoration of Passenger's Administrative and Port Operations Facilities Damaged by Typhoon Odette, Port of Surigao, Surigao City, Surigao Del Norte, in the websites of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila, on 19 December 2023, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 31,244,902.41**;

WHEREAS, in response to the said advertisement, two (2) bidders secured the Bid Documents in the amount of ₱ 25,000.00 and submitted their Technical and Financial Proposals, namely:

1. M.G. Salazar Construction Corp./B3 & R Construction Corp./JV
2. Orani Construction and Supply Corporation

WHEREAS, during the opening of bids on 18 January 2024 at 9:00 a.m., only M.G. Salazar Construction Corp./B3 & R Construction Corp./JV was declared "passing" with the requirements of the First Envelope. Orani Construction and Supply Corporation was declared "failed" with the requirements of the Technical Proposal, for the following reasons:

1. No capacity was indicated in the supporting documents for the pledged one (1) unit Welding Machine.
2. The validity period of the PRC License for the pledged Project Manager is unreadable/unverifiable.
3. Submitted invalid proof of authority for the Omnibus Sworn Statement signed by Mr. Dino M. Vianzon, considering that the submitted Secretary's Certificate appointed Ms. Analyn Viazon as its Authorized Representative.

WHEREAS, Orani Construction and Supply Corporation signified its intention to file a request for reconsideration, hence, the unopened Second Envelope was retained by the BAC, until the request for reconsideration has been resolved by the Committee;

WHEREAS, the Financial Proposal of M.G. Salazar Construction Corp./B3 & R Construction Corp./JV was opened and declared "passing" with the requirements of the Second Envelope, hence its financial bid was read by the Chairperson, as follows:

WHEREAS, Orani Construction and Supply Corporation filed its request for reconsideration on their "failed" rating, and in a meeting held on 24 January 2024, the BAC, after due deliberation, denied the request for reconsideration;

WHEREAS, Bid Evaluation was conducted on 24 January 2024 to determine if there were arithmetical or computational errors on the submitted bids, and the Bid Evaluation Report, as approved by the BAC on 24 January 2024, showed discrepancies between the Total Bid Prices and Unit Bid Prices of M.G. Salazar Construction Corp./B3 & R Construction Corp./JV;

WHEREAS, M.G. Salazar Construction Corp./B3 & R Construction Corp./JV was declared as the Single Calculated Bidder in the amount of ₱ 31,194,836.08;

WHEREAS, post-qualification was conducted on 31 January 2024 to examine, validate and verify the eligibility, technical and financial requirements submitted by M.G. Salazar Construction Corp./B3 & R Construction Corp./JV and in the Post-Qualification Report, as approved by the BAC on 02 February 2024, M.G. Salazar Construction Corp./B3 & R Construction Corp./JV was declared as the Single Calculated and Responsive Bidder;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED, to declare **M.G. SALAZAR CONSTRUCTION CORP./B3 & R CONSTRUCTION CORP./JV** as the Single Calculated and Responsive Bidder and to recommend the award of contract for the Restoration of Passenger's Administrative and Port Operations Facilities Damaged by Typhoon Odette, Port of Surigao, Surigao City, Surigao Del Norte, in the amount of **THIRTY ONE MILLION ONE HUNDRED NINETY FOUR THOUSAND EIGHT HUNDRED THIRTY SIX PESOS AND 08/100 (Php 31,194,836.08)**, inclusive of taxes, to the said bidder.
