**RESOLUTION DECLARING THE POST-DISQUALIFICATION OF WTG
CONSTRUCTION AND DEVELOPMENT CORPORATION FOR THE
PROPOSED DREDGING OF UBAY AND TALIBON PORTS, BOHOL
LFP BHL NO. 057-2018**

WHEREAS, the Philippine Ports Authority (PPA) posted an Invitation to Bid for the Proposed Dredging of Ubay and Talibon Ports, Bohol, in the website of the PPA, PhilGEPS and in the Bulletin Board located at the PPA Corporate Building, South Harbor, Port Area, Manila on 20 December 2018, continuously for seven (7) calendar days;

WHEREAS, the Approved Budget for the Contract to be Bid as posted/advertised is **₱ 152,318,336.95**;

WHEREAS, in response to the said advertisement, three (3) prospective bidders secured the Bid Documents in the amount of **₱ 50,000.00**, namely:

1. WTG Construction & Development Corporation
2. RT Crisman Builders and Construction Supply/JFAP Construction/
Joint Venture
3. Makapa Corporation

WHEREAS, only two (2) bidders dropped their Technical and Financial Proposals in the bid boxes located at the BAC Office, 5th Floor, PPA Building, namely: WTG Const. & Dev't. Corp. and RT Crisman Builders and Construction Supply/JFAP Const./JV. Makapa Corp. submitted its bid documents at 1:44 p.m. or after the prescribed deadline of 1:00 p.m., hence the same were not accepted by the BAC Secretariat, pursuant to the 2016 Revised IRR of R.A. 9184 on late submission of bids;

WHEREAS, during the opening of bids on 18 January 2019 at 2:00 p.m., the two (2) bidders were declared "passing" with the requirements of the First Envelope;

WHEREAS, the Financial Proposal of the two (2) bidders were opened and declared "passing" with the requirements of the Second Envelope, hence their financial bids were read by the Chairperson, as follows:

2. RT CRISMAN BUILDERS AND CONST. SUPPLY/JFAP CONST./JV	₱ 150,998,453.76

WHEREAS, Bid Evaluation was conducted on 22 January 2019 to determine if there were arithmetical or computational errors on the submitted bids. WTG Const. & Dev't. Corp. was declared as the Lowest Calculated Bidder in the amount of ₱ 141,755,976.57, pursuant to Section 34.4 of the 2016 Revised IRR of R.A. 9184;


WHEREAS, post-qualification was conducted on 26 January 2019 to examine, validate and verify the eligibility, technical and financial requirements submitted by WTG Const. & Dev't. Corp. and in the Post-Qualification Report, as approved by the BAC on 01 February 2019, WTG Const. & Dev't. Corp. was declared post-disqualified for failure to present the original copies of MARINA Certificate of Ownership and MARINA Cargo Ship Safety Certificate for the equipment, one (1) unit Non-Propelled Grab Dredger, Barge "WTG-6," owned and one (1) unit Tug-boat "Mtug Rosa II," owned;

NOW, THEREFORE, for and in consideration of the foregoing premises, the BAC hereby RESOLVE as it is hereby RESOLVED, as follows:


1. To declare **WTG CONSTRUCTION AND DEVELOPMENT CORPORATION** to be post-disqualified, for failure to present the original copies of MARINA Certificate of Ownership and MARINA Cargo Ship Safety Certificate for the equipment, one (1) unit Non-Propelled Grab Dredger, Barge "WTG 6", owned and one (1) unit Tug-boat "Mtug Rosa II", Owned.
2. To immediately notify **WTG CONSTRUCTION AND DEVELOPMENT CORPORATION** in writing of its post-disqualification and the grounds for it.
3. To initiate and complete the post-qualification process on the second lowest calculated bidder, **RT CRISMAN BUILDERS AND CONSTRUCTION SUPPLY/JFAP CONSTRUCTION/JOINT VENTURE**, pursuant to Section 34.6 of the 2016 Revised IRR of R.A. 9184.
